Friday (Gam, Std, Rly, Snk), Saturday (Snk, Std, Stp1, GPR), Sunday (Gam, Jmp, Std, Stp2)

The listings for Grand Prix and Perf. National Standard (GPR and PNS) are both listed as GRP on the confirmation. Make sure the jump height is correct. If we have you in the wrong class, we'll fix it up at the show :)

PLEASE VERIFY THAT YOUR USDAA REGISTRATION NUMBER IS CORRECT AND THAT YOUR DOG IS LISTED IN THE CORRECT CLASSES, LEVELS, AND JUMP HEIGHT. PLEASE NOTIFY ME ASAP OF ANY CORRECTIONS THAT MUST BE MADE. You can reach me at r2agility@verizon.net or 425-788-2247

If you sent in a copy of your permanent height card, you do not need to check in. If you do not have a permanent height card, you will need to check in and have your dog measured. Thurs night check-in will be from 7:00-7:30pm and requires permanent height card or USDAA check-in letter, there will be no measuring judge at the site. If your dog needs to be measured, do not check in Thurs night. There will be a measuring judge for check in 7:00-7:30am Friday, Saturday and Sunday. Friday and Sunday runs will start with small dogs, Saturday runs will start with tall dogs. First dog on the line at 8:00am.

Lunch will be provided to all workers, lunch will be provided to non-workers for a donation.
