Driving Directions to Crook County Fairgrounds, Prineville, OR

From the North (Madras): Take US-26 south to Prineville, Oregon. Turn right on N. Main St (SR-27) and go approximately ¾ mile to the entrance.

From the South/West (Redmond): Take SR-126 east to Prineville, Oregon. Continue east on US-26 (W 3rd St) for approximately ½ mile, then turn right on N. Main St (SR-27) and go approximately ¾ mile to the entrance.
