Driving Directions to Confluence State Park

From West Hwy 97 and 2: Exit the Highway at Easy Street. Turn right onto Easy Street and drive about ¼ mile to Penny Rd. Turn left onto Penny Rd and drive to Euclid Ave. Turn right onto Euclid and follow around to Olds Station Rd. The park entrance and sign will be on your left.

From East Hwy 97 and 2: Exit the Highway at Euclid Ave (follow State Park Signs). Turn left at the exit onto Euclid Ave. Follow it to Olds Station Rd and to the state park signs and entrance.

- Judges:** Gillian Crawford – Friday, Jo Ann Mather – Saturday & Sunday
- Height Order:** Friday & Saturday – Tall to SmallSunday – Small to Tall
- Measurements:** If you have not been measured or shown a height card, you must do so before you run. The gate sheets will be highlighted to indicate if you need to have your dog measured or show its card.
- Class Schedule:** Friday **9:00 AM**, Saturday **8:30 AM**, Sunday **8:30 AM** **The rings will run alternately.**

- Walkthroughs:** There will be a single walkthrough for each class. Exc Std will have split walkthrus, and Exc Jww may have a mini-split walkthrough.
