From the North, on I-5:

1. Take EXIT 234A toward Fair / Expo / Knox Butte.
2. Turn slight right onto Airport Road SE.
3. Turn right onto Pacific Blvd. SE / OR-99E N.
4. Stay straight to go onto Knox Butte Road E.
5. End at 3700 Knox Butte Road E.

From the South, on I-5:

1. Take Exit 234 toward Fair / Expo / Knox Butte.
2. Turn right onto Knox Butte Road E.
3. End at 3700 Knox Butte Road E.

Height Order: Saturday/Monday: Small to Tall Sunday: Tall to Small

Measurements: If you have not been measured or shown a height card, you must do so before you run. The gate sheets will be highlighted to indicate if you need to have your dog measured or show its card.

Start Times: Ring 1 starts at 8:30 AM each day. On the weekend, Ring 2 will start about ½ hour later.

Class Schedule: Saturday/Sunday - Rings will run at the same time.
Ring 1 - Nov FAST, Open FAST, Nov JWW, Open JWW, Exc JWW
Ring 2 - Exc Std, Open Std, Nov Std, Exc Fast
Monday – Rings will alternate
Ring 1 - Exc Std, Opn Std, Nov Std, Exc Fast, Opn Fast, Nov Fast
Ring 2 – Exc Jww, Opn Jww, Nov Jww

Walkthroughs: Open and Novice – There will be a single, timed, walkthrough for each class.
Excellent – Walkthrus may be split based on jump height groupings.
