## Running Order and Class Information

### *Driving Directions to Lane County Fairgrounds*

**From I-5:** Take I-105 (SR-126) West (exit 194B) for approximately 3.2 miles across the Willamette River. I-105 will end at the stoplight on 7<sup>th</sup> and Jefferson. Continue straight ahead on Jefferson and take a right at 11<sup>th</sup>. Go about 6 blocks to Tyler or Polk and turn left. Turn left again at 13<sup>th</sup> and look for the entrance to the Ice Arena on your right.

**Judges:** **Mr. Keith VanHousen & Mrs. Denise VanHousen**

**Height Order:** This is a different running order than normal, so make sure to read it very carefully!!!!

**Open, Novice, All FAST:** Friday and Sunday – Tall to Small. Saturday and Monday – Small to Tall.  
**Excellent** classes are broken into 3 groups: (4/8/12/16, 20, 24/26).

**Measurements:** If you have not been measured or shown a height card, you must do so before you run. The gate sheets will be highlighted to indicate if you need to have your dog measured or show its card.

**Class Schedule:** **Ring 1 – Exc Std, Opn Std, Nov Std, Exc Fast**  
**Ring 2 – Opn Fast, Nov Fast, Open Jww, Nov Jww, Exc Jww.**

**Start Times:** **First dog on the line:** Ring 1 - 8:30 AM, Ring 2 approx. 9:00 AM  
**Briefing/Walkthru:** about ½ hour before each ring starts  
**Checkin:** about 1 hour before each ring starts

**Walkthroughs:** **Open and Novice** – There will be a single walkthrough for each class.  
**Excellent** – walkthrus will be split in 3 groups (4/8/12/16, 20, 24/26) as indicated see “Height Order”.

**Setup:** Setup is available on Thursday afternoon.
