Running Order and Class Information

Driving Directions to Lane County Fairgrounds

From I-5: Take I-105 (SR-126) West (exit 194B) for approximately 3.2 miles across the Willamette River. I-105 will end at the stoplight on 7th and Jefferson. Continue straight ahead on Jefferson and take a right at 11th. Go about 6 blocks to Tyler or Polk and turn left. Turn left again at 13th and look for the entrance to the Ice Arena on your right.

Height Order: Thursday/Saturday: **Small to Tall** Friday/Sunday : **Tall to Small**
All Novice and Open classes plus the Fast classes will have one walkthrough.
Excellent Std and Jumpers will be split into groups.

Measurements: If you have not been measured or shown a height card, you must do so before you run. The gate sheets will be highlighted to indicate if you need to have your dog measured or show its card. A VMO/Rep is scheduled to be on site at least for the weekend.

Start Times: **First dog on the line:** Thursday at 10AM Ring 1, Friday-Sunday at 9AM Ring 1. Ring 2 will start after Exc Fast finishes (Thur-Sat) and about ½ hour after Ring 1 starts on Sunday.
Briefing/Walkthru: about ½ hour before each ring starts
Checkin: about 1 hour before each ring starts
