Driving Directions to Portland Expo Center

FROM I-5 NORTH OR SOUTHBOUND – Take exit 306B to get to the east side reserved/general parking entrance or take exit 307 Marine Dr. West to get to the Force Ave west side reserved parking entrance or to circle around the Expo to get to the exhibitor express entrance.

Judges: **Scott Stock & Kim Ingraham**

Height Order: This is the same schedule as last year. Hopefully it will work out as well in 2009. We hope that this schedule will allow those that want to help (hint-hint), go shopping, etc. plan their day better.

Open and Novice: Thursday & Saturday – Tall to Small. Friday & Sunday – Small to Tall.

Excellent classes are broken into 4 groups: (4/8/12, 16, 20, 24/26).

All FAST classes will run the Opn/Nov height order.

Measurements: It is YOUR responsibility to inform the trial secretary if your dog needs to be measured. If you didn't send in a height card or indicate that you have one, you will need to have your dog measured at the show. Please make sure to plan extra time BEFORE your run to get measured.

A measuring official will be at the show, so all measurements will be “official”.

Start Times (all days):

Ring 1 (STD)	7:45 AM – briefing, 8:00 AM first dog on the line
Ring 2 (JWW)	8:15 AM – briefing, 8:30 AM first dog on the line
Checkin	7:00 AM – measuring

Class Schedule:

Thurs/Friday: **Ring 1** – Exc Fast, Exc Std, Opn Std, Nov Std
Ring 2 – Nov Fast, Opn Fast, Nov Jww, Opn Jww, Exc Jww

Saturday/Sunday: **Ring 1** – Exc Std, Opn Std, Nov Std
Ring 2 – Nov Jww, Opn Jww, Exc Jww
ISC will run in the first available ring.

Walkthroughs: **Open and Novice** – There will be a single, timed, walkthrough for each class.
Excellent – Each height group listed above will have a timed walkthrough. *No mass-walkthrough is planned at this time.*

Moveups: The deadline for moveups is Monday Jan. 18^h, at 6PM. Moveups must be received in writing or email by that deadline. Day-to-Day moveups are being accepted for Friday, Saturday, and Sunday but must be received no later than ½ hour after the last class.

Setup: The agility area is being prepared on Wednesday morning. We anticipate that the area will be available for setup after 2PM, but don't have a firm time yet.

If you setup early and we need to move your stuff, we will. We plan on being there early on Wednesday afternoon and will coordinate setup at that time. There are some spaces reserved for our chief workers that will be identified on Wednesday.

Crating:

As indicated in the premium, there will be NO X-Pens, NO chairs, and NO “camps” allowed in the crating area. We have 330 dogs entered in the show over the 4 days and will all need to work together to fit into the limited crating area. If you have multiple dogs, you must plan on stacking your crates at least 2 high. If you have only 1 dog, you are not expected to stack crates.

The NO Chair rule will be strictly enforced. We apologize, but there will not be room for people to be putting chairs and camps in the crating area. There are chairs around the rings and bleachers for watching the runs. Please be kind and respect the rule. Crating is very tight and we need everybody’s help to make it work.

Potty Areas:

As indicated in the premium, it is a benchable offense to allow your dog to relieve themselves in the landscaped areas on the Expo site. This also extends to the business park to the West of the site. There are potty areas around the facility with shavings, so please use those.
