This trial will be held indoors at Argus Ranch.

### Driving Directions

#### From North or South End

Take I-5, I-405, SR-167 to Highway 18 eastbound. Exit onto Auburn-Black Diamond Road eastbound. Turn RIGHT onto SE Green Valley Road (just past Neely Mansion). Follow for about 7.5 miles. Turn RIGHT onto 212th Way SE

Take First LEFT into Argus Ranch and follow drive straight ahead to Arena and signed parking.

#### From Hwy. 410 or WA 164 (Auburn-Enumclaw Hwy.)

Turn LEFT onto 244th Ave. SE (approximately one mile out of Buckley) Go STRAIGHT at Light on SE 436th Way/WA-164. Go STRAIGHT at Stop Sign SE 416th St. Go STRAIGHT at Stop Sign SE 400th St. Turn LEFT at Stop Sign onto SE 384th St. Turn RIGHT at Stop Sign 212th WAY SE. Turn RIGHT at ARGUS RANCH Sign (just before Bridge). Follow drive STRAIGHT ahead to Arena and signed parking.

#### From SR 169 Southbound

Right onto Roberts Drive (in front of the Coal Car), go approximately four miles. Left onto 218th Street. At bottom of the hill is a stop sign. Go straight across over bridge (Whitney Bridge). Take First Left into Argus Ranch and follow drive straight ahead to Arena and signed parking.

#### From SR-169 Northbound

Turn LEFT onto SE Green Valley Road (in front of the Boondocks Nursery). Go about four miles. Turn LEFT onto 212th Way SE. Go over the Cement Bridge. (Whitney Bridge) Take First LEFT into ARGUS RANCH and follow drive straight ahead to Arena and signed parking.

**Judges:** Candy Nettles, Robyn Veenema, Jo Ann Mather

**IMPORTANT:** Due to the EXTREMELY large entry (almost 700 runs on Saturday), we are adjusting the judging from what was published in the premium. Jo Ann Mather will be judging some Exc Std and Jww on Saturday. Robyn Veenema will be judging some Exc Std on Sunday. See the schedule below for details.

**Measurements:** If you have not been measured or shown a height card, you must do so before you run. The gate sheets will be highlighted to indicate if you need to have your dog measured or show its card. **A VMO is scheduled to be at the show, so measurements will be official.**

**Start Times:** Friday: Noon Sat-Sun: 8:00 AM

**Walkthrus:** Novice, Open, and Exc Fast will have a single walkthrough. Exc Jww and Std will be split by height. The heights will run as indicated below in the Class Schedule and we will split the walkthroughs as needed. We will **most likely** do walk/run.  
Saturday groups will likely be: (4,8,12), (16), (20), (24,26)  
Sunday groups will likely be: (12,16), (4,8,24,26), (20)

**Veterinarian:** (after hours) Animal Emergency Clinic, 718 Auburn Way N., Auburn, WA (253) 939-6272  
**Directions:** From Argus Ranch – turn right from the Argus driveway, then left on Green Valley Rd for about 7 miles. Turn left on Auburn – Black Diamond road for about ¼ mile to the entrance to Hwy 18 West. Take Hwy 18 about 1.5 miles to the Auburn Way exit. Take a left at on Auburn way and drive for about 2 blocks to the clinic.

**Moveups:** The deadline for moveups is Monday April 12<sup>th</sup>, at 6PM. Moveups must be received in writing or email by that deadline. Day-to-Day moveups are being accepted for Saturday and Sunday but MUST be received no later than ½ hour after the last class of the current day.
