This trial will be held outdoors on grass at Argus Ranch.

We MAY move indoors if the weather is really bad or the grass is not suitable for the show.

Driving Directions

From North or South End

Take I-5, I-405, SR-167 to Highway 18 eastbound. Exit onto Auburn-Black Diamond Road eastbound. Turn RIGHT onto SE Green Valley Road (just past Neely Mansion). Follow for about 7.5 miles. Turn RIGHT onto 212th Way SE. Take First LEFT into Argus Ranch and follow drive straight ahead to Arena and signed parking.

From Hwy. 410 or WA 164 (Auburn-Enumclaw Hwy.)

Turn LEFT onto 244th Ave. SE (approximately one mile out of Buckley). Go STRAIGHT at Light on SE 436th Way/WA-164. Go STRAIGHT at Stop Sign SE 416th St.. Go STRAIGHT at Stop Sign SE 400th St. Turn LEFT at Stop Sign onto SE 384th St.. Turn RIGHT at Stop Sign 212th WAY SE. Turn RIGHT at ARGUS RANCH Sign (just before Bridge). Follow drive STRAIGHT ahead to Arena and signed parking.

From SR 169 Southbound

Right onto Roberts Drive (in front of the Coal Car), go approximately four miles. Left onto 218th Street. At bottom of the hill is a stop sign. Go straight across over cement bridge (Whitney Bridge). Take First Left into Argus Ranch and follow drive straight ahead to Arena and signed parking.

From SR-169 Northbound

Turn LEFT onto SE Green Valley Road (in front of the Boondocks Nursery). Go about four miles. Turn LEFT onto 212th Way SE. Go over the Cement Bridge. (Whitney Bridge) Take First LEFT into ARGUS RANCH and follow drive straight ahead to Arena and signed parking.

Indoor vs Outdoor: We are scheduled to be outdoors on the grass if the weather and grass conditions permit. We will not know until next Wednesday or Thursday the week of the trial if those conditions will allow us to be outdoors. If we go indoors, an email will be sent on Wed or Thurs indicating our new location.

- Measurements:** If you have not been measured or indicated that you have a height card, you must do so before you run. We are scheduled to have a VMO at the show.
- Start Times:** Friday – 10:00 AM Saturday/Sunday – 8:30 AM
- Walkthroughs:** **Open and Novice plus Exc Fast** – There will be a single, timed, walkthrough for each class.
Excellent – Walkthrus will be split based on jump height groupings as shown above.
- Veterinarian:** (after hours) Animal Emergency Clinic, 718 Auburn Way N., Auburn, WA (253) 939-6272
Directions: From Argus Ranch – turn right from the Argus driveway, then left on Green Valley Rd for about 7 miles. Turn left on Auburn – Black Diamond road for about ¼ mile to the entrance to Hwy 18 West. Take Hwy 18 about 1.5 miles to the Auburn Way exit. Take a left at on Auburn way and drive for about 2 blocks to the clinic.
- Moveups:** The deadline for move-ups is Monday May 16th, at 6PM. Move-ups must be received in writing or email by that deadline. Day-to-Day move-ups are being accepted for Saturday and Sunday.
- Crating:** **Outdoors** - There will be space around the rings for canopies and crates.
Indoors – space is more limited, so please be nice 😊
- Setup:** Setup for canopies and crates is allowed after the rings are setup on Thursday (about 4 PM).
- RVs:** Overnight parking at Argus needs to be arranged directly with Argus Ranch.
- Workers:** We are using the white board for workers. Please help out where you can 😊.
