Measurements: If you do not have a valid height card, you will need to have your dog measured. Two measuring officials are scheduled to be at the show so you can get a permanent card.

Walkthroughs: **Open, Novice, Fast** – There will be a single, timed, walkthrough for each class.

Excellent – Each height group listed above will have a timed walkthrough. No mass-walkthrough is planned at this time.
We will walk a group, 5 minutes to first dog, and then run that group.

Moveups: The deadline for moveups is Monday Jan 30th at 6PM. Moveups must be received in writing or email by that deadline. Day-to-Day moveups are accepted for Saturday & Sunday and must be received by ½ hour after the trial ends each day.

Special Notes: **Conflicts** – AKC only recognizes conflicts “at the show”. Things that happen outside the show don’t apply as a conflict. If you have a conflict, indicate that on the gate sheets with the gate steward. Conflicts within the show will be accommodated as best as is possible.

Moving your dogs – DO NOT move dogs by yourself. Often, if you move, it will mess up somebody else. See Mrs. Robin at the score table if you need to move your dogs.

Missing your run – If you are not at the start line when it’s your turn to run, you have missed it and most likely will NOT be allowed to run. If you have a conflict, indicate it with the gate steward (see above).

Crating: There is abundant crating at the site. All crating is on concrete around the ring boundaries, except for the south wall area which is reserved for vendors. Please do not block entrances and exits and do not crate on any elevated platform around the rings. This facility is indoors and NOT heated. Bring appropriate clothing and blankets. **Propane heaters are NOT allowed in the show building.** You may bring an electric heater – there are limited plug ins around the rings, but no more than three heaters per circuit or the breaker will shut off.

Parking: Parking is in any marked spot around the building. Do not block any arena entrances or access roads. Do not park in the RV parking areas (south side of the building and directly across the road on the south side).

Camping: Camping is on the south side of the arena building against the building or across the road on the gravel area. You may arrive for camping on Thursday, but spaces are not confirmed before 5:00 so we can accommodate some reserved spaces – if you arrive before 5PM on Thursday you may be asked to move. **There is NO camping on the north side of the arena.**

Volunteers: We are using the white board system for volunteer sign-ups. Please help out where you can and check with the chief ring steward to sign up. A \$5 voucher will be given for each class worked. Vouchers can be used at the on-site food vendor or applied to future MHDPC trials. Worker tickets MUST be turned in by the end of the weekend to be exchanged for a trial entry voucher. **Some spots on Saturday and Sunday will be staffed by 4H, but we will need plenty of help. Please make your lunch plans accordingly ☺**

Chewy’s is scheduled be on-site as our food vendor, offering an array of breakfast and lunch items, snacks, and beverages.

Clean Up: Please clean up after your dogs. We want to keep using this site in the future and need your help to keep it clean ☺
